REACH European Regulation (Registration, Evaluation and Authorisation of Chemicals)

The REACH regulation (n.1907/2006) regarding the registration, evaluation and authorisation of chemicals came into force, for all intents and purposes, on the 1st June 2007.

In compliance with the provisions of the REACH regulation, whoever manufactures or imports in EU countries a substance, and / or if a substance is contained in a chemical preparation in a quantity which is equal to or more than a ton per year, must register with the European Agency for Chemical Substances (European Chemical Agency ECHA) in Helsinki, Finland, according to procedures and within different time periods depending on the quantity produced and/or imported and on the dangerousness of the substance itself.

With reference to what is provided for by the REACH Regulation, SAURO hereby declares that it neither produces nor imports chemical substances; however, as a consumer of raw materials, it collaborates with suppliers to ensure REACH regulation is properly followed.

SVHC list and attachments XVII and XIV ingredient compound

The REACH regulation also pertains to the use of chemical substances for which the alert level remains high (Substances of Very High Concern "SVHC" and attachment XIV and XVII) and restricts their production, their commercialization, and use as an element of a composite or in a product, as they could pose potential severe consequences on human health and the environment.

Sauro requires from all of its suppliers that the substances noted on the SVHC list and in attachments XIV and XVII, including their amendments and additions possibly present in the materials supplied by them, are recorded in full compliance with the regulation.

Based on the declarations of its suppliers, Sauro certifies that the products belonging to the series MSD, MSDH, MTB, MTBH, MTS, MSB, MSBH, MSBD, MSG, MSGH, MSFH, MSM, MSMH, MSS, MSQ, MSQH, MSP, MSPH, MPS, PSB, PSBH, PSM, PSQ, CLF, CTF, CKF, CSF, CXF, CIF, COF, CUF, CVF, CGM and CYF do not contain any of the substances mentioned in the SVHC and in attachments XIV and XVII, as of June 25th 2020 in concentrations higher than 0.1% (w/w) except for the following:

Packaging and products belonging to the series MMP, MPP, MMT, MCCH, MCB, MCBH, MCBD, MCM, MCMH, MCQ, CHF, CLM, CLMH, CBF, CTM, CTMH, CSM, CSMH, CIM, CIMH, COM, CPM, CPMH, CRM, CCF, CGF, CYM, STC, SMC and SRC do not contain any of the substances mentioned in the SVHC and in attachments XIV and XVII in concentrations higher than 0.1% (w/w) at the time of the revision date of this information sheet.
